4. **Haldia Development Authority (HDA)** will execute the work.

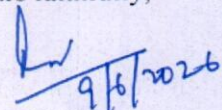
5. **The Chief Executive Officer, Haldia Development Authority (HDA)** will be act as **DDO** in this respect.

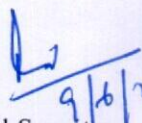
