I am directed by order of the Governor to say that the Governor has been pleased to accord administrative approval in respect of the scheme "*Partial Silt clearance of different drains or Khals under Central Division, in order to prevent water logging problem and management of vector borne diseases and to ensure smooth drainage of water*" at an estimated cost of Rs. 67,20,455/- (Rupees sixty seven lakh twenty thousand four hundred fifty five) only subject to:-

- (i) Strict observance of all relevant Financial Rules & Regulations including E-Tender and EMD Rules in force and added and amended from time to time.
- (ii) Timely completion of work to avoid escalation of cost; and

4. The Kolkata Metropolitan Development Authority will execute the project.

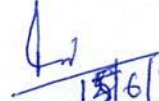
