I am directed by order of the Governor to say that the Governor has been pleased to accord administrative approval in respect of the scheme "Restoration of Bituminous and Concrete Road from Mejuti Bridge to Sadhukhan Para under Jholabiswanathpur G.P. and Charapanchla G.P., Panchla A.C., Howrah" at an estimated cost of Rs. 78,87,758/- (Rupees seventy eight lakh eighty seven thousand seven hundred fifty eight) only subject to:-

4. The Kolkata Metropolitan Development Authority will execute the project.
