I am directed by order of the Governor to say that the Governor has been pleased to accord administrative approval in respect of the scheme "Desiltation of Balitikuri Khal from Dasnagar Railway Jheel to Howrah Amta Railway line under Howrah Municipal Corporation" at an estimated cost of Rs. 36,37,929/- (Rupees thirty six lakh thirty seven thousand nine hundred twenty nine) only subject to:-

- (i) Strict observance of all relevant Financial Rules & Regulations including E-Tender and EMD Rules in force and added and amended from time to time.
- (ii) Timely completion of work to avoid escalation of cost; and
- (iii) Non-diversion of Fund.

4. The Kolkata Metropolitan Development Authority will execute the project.

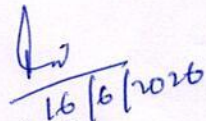
