I am directed by order of the Governor to say that the Governor has been pleased to accord administrative approval in respect of the scheme "Desiltation of alongside of Shalimar Railway track from railway culvert no. 4 to railway culvert no. 06 under Howrah Municipal Corporation" at an estimated cost of Rs. 26,55,834/- (Rupees twenty six lakh fifty five thousand eight hundred thirty four) only subject to:-

- (i) Strict observance of all relevant Financial Rules & Regulations including E-Tender and EMD Rules in force and added and amended from time to time.
- (ii) Timely completion of work to avoid escalation of cost; and
- (iii) Non-diversion of Fund.

4. The Kolkata Metropolitan Development Authority will execute the project.

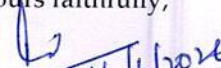
