I am directed by order of the Governor to say that the Governor has been pleased to accord administrative approval in respect of the scheme "Desiltation of DVC canal from DVC sub-station to Padma pukur Branch-VI under Howrah Municipal Corporation" at an estimated cost of Rs. 23,05,138/- (Rupees twenty three lakh five thousand one hundred thirty eight) only subject to:-

- (i) Strict observance of all relevant Financial Rules & Regulations including E-Tender and EMD Rules in force and added and amended from time to time.
- (ii) Timely completion of work to avoid escalation of cost; and
- (iii) Non-diversion of Fund.

I am further directed to say that the expenditure for the said project shall be debitable to the head of account '2217-Urban Development -05-OTHER URBAN DEVELOPMENT SCHEMES-191-Assistance to Local Bodies Corporations, Urban Development Authorities, Town Improvement Boards, etc.-State Development Scheme- 145-Grants-in-aid to Kolkata Metropolitan Development Authority (KMDA) for Development Schemes/ Activities-31-Grants-in-aid-GENERAL-02-Other Grants' (2217-05-191-00-145-31-02-V) under Demand No. 72-UM in the State Budget.

4. The Kolkata Metropolitan Development Authority will execute the project.

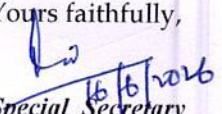

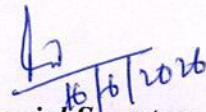
