I am directed by order of the Governor to say that the Governor has been pleased to accord administrative approval in respect of the scheme “Desiltation of Pocha Khal from A-Road culvert near Rani Jheel to Biradingi(Where Branch channel III starts) under Howrah Municipal Corporation” at an estimated cost of Rs. 28,71,748/- (Rupees twenty eight lakh seventy one thousand seven hundred forty eight) only subject to:-

- (i) Strict observance of all relevant Financial Rules & Regulations including E-Tender and EMD Rules in force and added and amended from time to time.
- (ii) Timely completion of work to avoid escalation of cost; and
- (iii) Non-diversion of Fund.

4. The Kolkata Metropolitan Development Authority will execute the project.

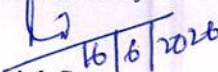

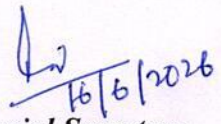
