*Administrative approval for "Cleaning, Jungle Cutting, removal of debris, water Hyacinth, weeds and floating materials of 1 No. Drains/Non irrigation channels above 2.5m width at different locations within time to time (as and when required) within Panihati Municipal area, for maintaining smooth drainage path throughout for 6(six) months"*

Sir,

I am directed by order of the Governor to say that the Governor has been pleased to accord administrative approval in respect of the scheme "Cleaning, Jungle Cutting, removal of debris, water Hyacinth, weeds and floating materials of 1 No. Drains/Non irrigation channels above 2.5m width at different locations within time to time (as and when required) within Panihati Municipal area, for maintaining smooth drainage path throughout for 6(six) months" at an estimated cost of Rs. 43,95,690/- (Rupees forty three lakh ninety five thousand six hundred ninety) only subject to:-

- (i) Strict observance of all relevant Financial Rules & Regulations including E-Tender and EMD Rules in force and added and amended from time to time.
- (ii) Timely completion of work to avoid escalation of cost; and
- (iii) Non-diversion of Fund.

I am further directed to say that the expenditure for the said project shall be debitable to the head of account '2217-Urban Development-05-OTHER URBAN DEVELOPMENT SCHEMES-191- Assistance to Local Bodies Corporations, Urban Development Authorities, Town Improvement Boards, etc.-State Development Scheme-145-Grants-in-aid to Kolkata Metropolitan Development Authority (KMDA) for Development Schemes/ Activities-31-Grants-in-aid-GENERAL-02-Other Grants' (2217-05-191-00-145-31-02-V) under Demand No. 72-UM in the State Budget.

4. The Kolkata Metropolitan Development Authority will execute the project.

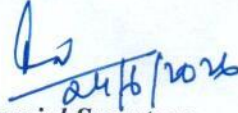
