I am directed by order of the Governor to say that the Governor has been pleased to accord administrative approval in respect of the scheme "**Desilting of Canal-B from backside of Malancha to Eden Court at AA-II, Newtown**" at an estimated cost of **Rs. 99,19,725/-** (*Rupees Ninety nine lakh nineteen thousand seven hundred twenty five*) only subject to:-

- (i) Strict observance of all relevant Financial Rules & Regulations including E-Tender and EMD Rules in force and added and amended from time to time.
- (ii) Timely completion of work to avoid escalation of cost; and
- (iii) Non-diversion of Fund.
- (iv) Submission of UC within stipulated time.

4. The New Town Kolkata Development Authority will execute the project.

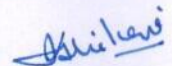

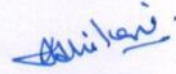
