I am directed by order of the Governor to say that the Governor has been pleased to accord administrative approval in respect of the scheme **"Supply and Installation of GI Octagonal Poles including supplying, fitting, fixing the street lights at the street Nos. 895, 818, 820, 822, 911, 846, 927, 925, 917, 825, 754 and 827 (total 76 poles) in AA-III, NKDA Newtown, Kolkata"** at an estimated cost of **Rs. 44,47,585.00** (Rupees Forty Four Lakh Forty Seven Thousand Five Hundred Eighty Five) only subject to:-

- (i) Strict observance of all relevant Financial Rules & Regulations including E-Tender and EMD Rules in force and added and amended from time to time.
- (ii) Timely completion of work to avoid escalation of cost; and
- (iii) Non-diversion of Fund.
- (iv) Submission of UC within stipulated time.

I am further directed to say that the expenditure for the said project shall be debitable to the head of account '2217-Urban Development-05-OTHER URBAN DEVELOPMENT SCHEMES-191-Assistance to Local Bodies Corporations, Urban Development Authorities, Town Improvement Boards, etc.-143-Development Schemes of KMDA, HIT, Kalyani Township and NKDA-35- Grants for creation of Capital Assets-00-V' (72-2217-05-191-00-143-35-00-V) under Demand No. 72-UM in the State Budget.

4. The New Town Kolkata Development Authority will execute the project.

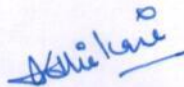
