4. **Birsingha Development Authority (BSDA)** will execute the work.

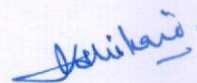
5. **The Executive Officer, Birsingha Development Authority (BSDA)** will be act as **DDO** in this respect.

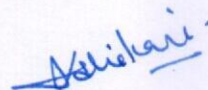
