- (ii) Timely completion of work to avoid escalation of cost; and
- (iii) Non-diversion of Fund.

4. The Kolkata Metropolitan Development Authority will execute the project.

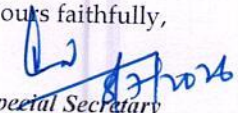

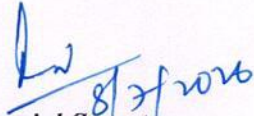
