I am directed by order of the Governor to say that the Governor has been pleased to accord administrative approval in respect of the scheme "Repair, renovation and beautification of the adjacent area of Hatishala Ghat, including paved area, stair area and sitting area and construction of retaining wall under Baidyabati, Hooghly" at an estimated cost of Rs. 34,93,465/- (Rupees thirty four lakh ninety three thousand four hundred sixty five) only subject to:-

- (i) Strict observance of all relevant Financial Rules & Regulations including E-Tender and EMD Rules in force and added and amended from time to time.
- (ii) Timely completion of work to avoid escalation of cost; and
- (iii) Non-diversion of Fund.

I am further directed to say that the expenditure for the said project shall be debitable to the head of account '2217-Urban Development-05-OTHER URBAN DEVELOPMENT SCHEMES-191- Assistance to Local Bodies Corporations, Urban Development Authorities, Town Improvement Boards, etc.-State Development Scheme-145-Grants-in-aid to Kolkata Metropolitan Development Authority (KMDA) for Development Schemes/ Activities-31-Grants-in-aid-GENERAL-02-Other Grants-V-Voted' (2217-05-191-00-145-31-02-V) under Demand No. 72-UM in the State Budget.

4. The Kolkata Metropolitan Development Authority will execute the project.

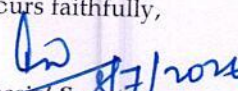

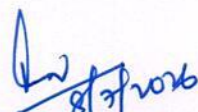
