4. **Burdwan Development Authority (BDA)** will execute the work.

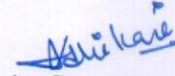
5. **The Chief Executive Officer, Burdwan Development Authority (BDA)** will be act as **DDO** in this respect.

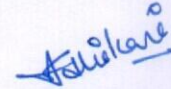
