I am directed by order of the Governor to say that the Governor has been pleased to accord administrative approval in respect of the scheme "Repair and up-gradation of various roads in different wards under Howrah Municipal Corporation and nearby areas to HMC jurisdiction (Part-4)" at an estimated cost of Rs. 2,93,31,691/- (Rupees two crore ninety three lakh thirty one thousand six hundred ninety one) only subject to:-

- (i) Strict observance of all relevant Financial Rules & Regulations including E-Tender and EMD Rules in force and added and amended from time to time.
- (ii) Timely completion of work to avoid escalation of cost; and
- (iii) Non-diversion of Fund.

4. The Kolkata Metropolitan Development Authority will execute the project.

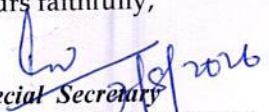

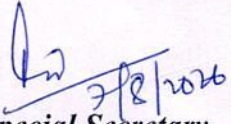
