I am directed by order of the Governor to say that the Governor has been pleased to accord administrative approval in respect of the scheme “Repairing of existing street lights and decorative lights in the road connecting Nemai Tirtha Ghat to Chowmatha and adjacent road of Gouriya Math in connection with Shrabani Mela 2026 at Tarakeshwar” at an estimated cost of Rs. 7,39,785/- (Rupees seven lakh thirty nine thousand seven hundred eighty five) only subject to:-

- (i) Strict observance of all relevant Financial Rules & Regulations including E-Tender and EMD Rules in force and added and amended from time to time.
- (ii) Timely completion of work to avoid escalation of cost; and
- (iii) Non-diversion of Fund.

I am further directed to say that the expenditure for the said project shall be debitable to the head of account ‘2217-Urban Development -05-OTHER URBAN DEVELOPMENT SCHEMES-191-Assistance to Local Bodies Corporations, Urban Development Authorities, Town Improvement Boards, etc.-State Development Scheme- 145-Grants-in-aid to Kolkata Metropolitan Development Authority (KMDA) for Development Schemes/ Activities-31-Grants-in-aid-GENERAL-02-Other Grants’ (2217-05-191-00-145-31-02-V) under Demand No. 72-UM in the State Budget.

3. This issues with the concurrence of the Financial Advisor of this Department vide U.O. No. 259/U.D. & M.A. dated 06.08.2026.

4. The Kolkata Metropolitan Development Authority will execute the project.

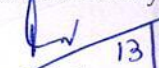

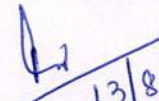
