I am directed by order of the Governor to say that the Governor has been pleased to accord 1st revised administrative approval in respect of the scheme "Construction of storm water RCC cover drain from Pallab Sardar house to Sonamukhi main canal up to H/O Kartik Naskar with restoration of road and construction of brick cover drain around the Akhanda Mahapit Ashram and construction of RCC cover slab over existing drain Pallab Sardar House Under Asuti-II Gram Panchayat, Thakurpukur Maheshtala Block" at an estimated cost of Rs. 2,35,98,841/- (Rupees two crore thirty five lakh ninety eight thousand eight hundred forty one) only.

4. The Kolkata Metropolitan Development Authority will execute the project.

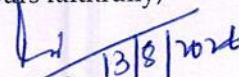
