I am directed by order of the Governor to say that the Governor has been pleased to accord administrative approval in respect of the scheme "Construction of RCC Pucca covered drain starting from new KMDA water reservoir front gate via backside of Vivekananda School to Ghoshpara Road, Amulyakanan and Baishalipara area within Rajyadharpur Gram Panchayet" at an estimated cost of Rs. 2,28,19,331/- (Rupees two crore twenty eight lakh nineteen thousand three hundred thirty one) only subject to:-

- (i) Strict observance of all relevant Financial Rules & Regulations including E-Tender and EMD Rules in force and added and amended from time to time.
- (ii) Timely completion of work to avoid escalation of cost; and
- (iii) Non-diversion of Fund.

4. The Kolkata Metropolitan Development Authority will execute the project.

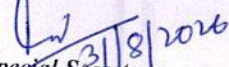
