4. The Kolkata Metropolitan Development Authority will execute the project.

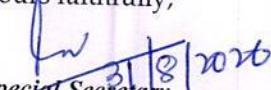

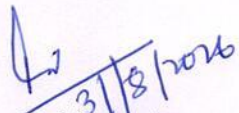
