
WHEREAS it has been brought into notice of the Department of Urban Development and Municipal Affairs that during issuance/renewal of Certificate for enlistment of profession, trade and callings commonly known as Trade License, some of the Urban Local Bodies are levying application fees in excess of ceiling prescribed under the relevant Act;

AND WHEREAS the Urban Local Bodies may levy application fees for issuance/renewal of Certificate for enlistment of profession, trade and callings at rate not exceeding the amount noted in the following table:

Sl. No.	Urban Local Body	Relevant provisions of Acts	Maximum prescribed rate
1.	Municipalities, Notified Area Authorities and Industrial Township Authorities	Section 118 of the West Bengal Municipal Act, 1993	Rupees one thousand and five hundred per annum
2.	Municipal Corporations except Kolkata Municipal Corporation and Howrah Municipal Corporation	Section 141 of the West Bengal Municipal Corporation Act, 2006	Rupees two thousand and five hundred per annum
3.	Howrah Municipal Corporation	Section 102 of the Howrah Municipal Corporation Act, 1980	Rupees two thousand and five hundred per annum
4.	Kolkata Municipal Corporation	Section 199 of the Kolkata Municipal Corporation Act, 1980	Rupees two thousand and five hundred per annum

NOW THEREFORE all the Urban Local Bodies are hereby requested to adhere to the provisions of the respective Act strictly and not to levy any other fees except application fees in contravention of the ceiling limit prescribed under the Act referred above, during issuance/ renewal of Certificate for enlistment of profession, trade and callings commonly known as Trade License.


