

Act XXII of 1993) (hereinafter referred to as the said Act), the Governor, after previous publication, is pleased hereby to make the following amendment in the West Bengal Municipal Employees' (Recruitment) Rules, 2005, published under this Department's notification No.443/MA/O/C-4/3C-5/2001 dated the 12<sup>th</sup> day of September, 2006 (hereinafter referred to as the said rules):-

**Amendment**

In sub-rule (1) of rule 4 of the said rules, after entry 18B, insert the following entry:-

“18C. Superintending Engineer:  Method of recruitment and Qualification:	By promotion, on the basis of seniority-cum-merit and performance of the employees in the regular post of Executive Engineer with at least eight years experience in the said post in municipal works.


