NOW, THEREFORE, in exercise of the powers conferred by sub-section (3) of section 431 of the said Act, the Governor, for the purpose stated above, is pleased hereby to appoint the Sub-Divisional Officer, Sadar Krishnanagar, Nadia as Administrator of the said municipality with immediate effect for a period not exceeding six months or until the newly elected Board of Councillors take over charge, whichever is earlier.
