
WHEREAS the Board of Councillors of the Purulia Municipality in the district of Purulia (hereinafter referred to as the said Municipality) has been dissolved under sub-section (2) of section 431 of the West Bengal Municipal Act, 1993 (West Ben. Act. XXII of 1993) (hereinafter referred to as the said Act), vide this Department's order No. 949/UDMA-15011(22)/18/2025-LS-MA SEC, Dated, Kolkata, the 16<sup>th</sup> December, 2025;

AND WHEREAS with the dissolution of the said Municipality, an administrative vacuum has occurred in the said Municipality, which is required to be filled up to ensure smooth running of the civic services in the municipal area of the said Municipality in the public interest;

AND WHEREAS in terms of provisions of sub section (3) of section 431 of the said Act, consequent to dissolution of a Municipality, all the powers and functions vested upon the municipal authorities under this Act or any other law for the time being in force, shall be exercised by such person or persons to be designated as Administrator or Board of Administrators as the State Government may appoint for the purpose in this behalf;

NOW, THEREFORE, in exercise of the powers conferred by sub-section (3) of section 431 of the said Act, the Governor, for the purpose stated above, is pleased hereby to appoint the Sub-Divisional Officer, Purulia Sadar as Administrator of the said Municipality with immediate effect for a period not exceeding six months or until the newly elected Board of Councillors take over charge, whichever is earlier.




