West Bengal Act XIV of 2026

**THE KOLKATA MUNICIPAL CORPORATION
(AMENDMENT) ACT, 2026.**

An Act to amend the Kolkata Municipal Corporation Act, 1980.

WHEREAS it is expedient to amend the Kolkata Municipal Corporation Act, 1980, for the purposes and in the manner hereinafter appearing;

West Ben. Act
LIX of 1980.

It is hereby enacted in the Seventy-seventh Year of the Republic of India, by the Legislature of West Bengal, as follows:—

Short title and
commencement.

1. (1) This Act may be called the Kolkata Municipal Corporation (Amendment) Act, 2026.

(2) It shall come into force on such date as the State Government may, by notification in the *Official Gazette*, appoint.

2. In section 5 of the Kolkata Municipal Corporation Act, 1980,—

(i) in clause (a) of sub-section (1), for the words “one hundred and forty-four elected Councillors”, the words “two hundred and nine elected Councillors” shall be substituted;

(ii) in sub-section (2), for the words “one hundred and forty-four Councillors”, the words “two hundred and nine Councillors” shall be substituted.
