ORDER

WHEREAS the lessee **Asian Informatics Pvt. Ltd.** vide their letter, dated 04.07.2024 applied for assignment of SBUA 5793.77 sq. ft. and car parking space 405 sq. ft. (135x3) along with proportionate undivided share of land in favour of **Reska Realtors Pvt.
