ORDER

WHEREAS the lessee **Kothari Hosiery Factory** vide their letter, dated 19.11.2024 applied for assignment of SBUA 1102 sq. ft. and car parking space 62 sq. ft. along with proportionate undivided share of land in favour of **Latika Infotech Private Limited** in respect of Unit No: 401 at 4th floor of the premises at plot no: DN-10, Sector-V, Salt Lake, Kolkata-700091 for IT/ITeS purpose.

AND WHEREAS the DPR of the above mentioned proposed transferee has been approved by the WBEIDCL for utilization on IT/ITES purpose;

AND WHEREAS in terms of this Department's order No. 205-UDMA-27012(11)/92/2024-LMNR SEC-Dept. of UDMA, dated 06.03.2026 and subsequent order no. 342-UDMA-27012(11)/92/2024-LMNR SEC-Dept. Of UDMA, dated 21.04.2026, the lessee has deposited the necessary permission fees for assignment of SBUA and car parking space with proportionate undivided share of the leasehold right of land as shown against the said company as mentioned below:-

NOW, THEREFORE, after careful consideration of the matter and in terms of this Department's Notification No. 5081-UD/O/M/SL(AL/NR)8L-08/04, dated 26.11.2012 & Notification no. 1675-UD/O/M/SL(AL/NR)/8L-08/2004, dated 06.05.2008, the undersigned is directed by order of the Governor to say that the Governor has been pleased to grant permission in favour of the lessee **Kothari Hosiery Factory** for regularization of post-facto assignment of the SBUA of 1102 sq. ft. along with car parking space of 62 sq. ft. with proportionate undivided share of land to **Latika Infotech Private Limited** in respect of Unit No: 401 at 4th floor of the premises at plot no: DN-10, Sector-V, Salt Lake, Kolkata-700091 for IT/ITeS purpose as mentioned in the table above for the remaining period of lease subject to execution and registration of a deed of assignment in conformity with the original lease deed.
