

Moreover, remaining amount of security deposit shall be deducted from the running account bill of the agency to cover up 10% (ten percent) of the total value of the work executed.

Intending tenderers must apply to the undersigned in writing together with documentary evidences in support of their experience and competency to execute such type of works along with valid **Trade License, PAN Card, GST Reg. Certificate, P.T, I.T Return, Credential**, for obtaining permission from undersigned to purchase tender documents for the work. Details of work, specification etc. can be seen from the office of the undersigned. Tender paper shall be purchased from office of the Executive Engineer, Central Mechanical Division.
