

The earnest money shall be converted as part security, the balance S.D will be deducted from each progressive bill.

If any Participant withdraw his quotation before its acceptance or refusal from the date of opening of quotation, without giving any satisfactory reasons, he shall be disqualified for submitting any tender to this Department for a minimum period of one year. The corresponding earnest money also be forfeited.
 9. Contractor shall be presumed to have inspected the site of works before submission of quotation.
 10. Conditional quotation will be nullified by the quotation accepting authority.
 11. All corrections in the quotation are to be signed and dated by contractors. Illegible, irregular, incomplete quotations are liable to rejection.


